WAIVER, ASSUMPTION OF RISK AND AGREEMENT TO HOLD HARMLESS
Ups 'N Downs Agility Club
July 1, 2009 – June 30, 2010

I understand that attendance at an Ups 'N Downs Agility Club of North San Diego County (hereinafter referred to as the "Club") sponsored training session, sporting event or other function including use of training fields, event grounds and equipment is not without risk to myself, members of my family, any person accompanying me, or my dog, because some of the dogs to which I (we) will be exposed, including my own, may be difficult to control and may be the cause of injury even when handled with the greatest amount of care. I also acknowledge that there is an inherent risk in utilizing any type of training or sporting event equipment selected for such purpose, especially that designed and used for the sport of agility

In consideration of and as an inducement to the acceptance of my application for membership in the Club, I hereby waive and release the Club, its members, trainers, employees, officers, and agents from any and all claims for injury or damages (including legal fees) which I, any member of my family, any other person accompanying me, or my dog may suffer, including specifically, but not without limitation, any injury or damage resulting from the action of any dog, including my own, contact with or use of any equipment, property fixtures, training fields or event grounds and surrounding areas thereto and I expressly assume the risk of any such damage or injury while attending any Club sponsored training session, sporting event or other function, or while on a training field, event grounds, or any other site selected for a Club function and surrounding areas thereto. I further agree to hold the Club, its members, trainers, employees, officers, and agents harmless from any claim or loss of my dog(s) by disappearance, theft, death or otherwise, and from any claim for damage or injury to my dog(s), whether any claim be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned.

I also agree to indemnify and to hold harmless, the Club, its members, trainers, employees, officers, and agents and shall personally assume any and all responsibilities and liability for any loss or injury which may be alleged to have been caused directly or indirectly to any person, dog, or property by the act of my dog, myself, my family member or any other person accompanying me while participating in a Club sponsored training session, sporting event or other function, held at any training field or event grounds, or any other site selected for a Club function including surrounding areas thereto.

I also understand that it is my personal responsibility to maintain control of any dog in my care and custody while attending any Club sponsored training session, sporting event or other function.

**WAIVER, ASSUMPTION OF RISK AND AGREEMENT TO HOLD HARMLESS

In consideration of and as inducement to the acceptance of my utilization of your training facility, I hereby waive and release Chris Libs d.b.a. SDRC, LLC, its employees, officers, members and agents, including, but not limited to, Ups N Downs Agility Club, from any and all liability of any nature for injury or damage which I, my family and guests, or my dog may suffer, including specifically, but without limitation, any injury or damage resulting from the action of any dog, contact with or use of, by either my dog, myself or my guests, any equipment, property fixtures or the training field and surrounding area thereto and I expressly assume the risk of such damage or injury while attending any training session or any other function of SDRC, LLC, or while on the training grounds or the surrounding area thereto.

I also agree to indemnify and to hold harmless, Chris Libs, SDRC, LLC, its employees, officers, members and agents including, but not limited, to Ups N Downs Agility Club, from any and all claims, or claims by any member of my family or any other person accompanying me to any training session, the training grounds or function of SDRC, LLC, or while on the grounds or the surrounding area thereto, as a result of any action by any dog, including my own, any equipment, property fixtures or the training field and surrounding area thereto. I shall personally assume any and all responsibilities and liabilities for any loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of my dog or myself while participating in a SDRC, LLC dog training program or while on the training grounds or the surrounding area thereto.

(My dog in the above statements means any dog in my custody upon approaching the training grounds or adjacent area.)
